Application Fee – A \$25 non-refundable application fee must be received with this application. Upon receipt of this application including the 200 word essay a phone interview will be scheduled to determine your acceptance into the program. Upon acceptance into the program a completed Enrollment Agreement and \$500 deposit is required to hold your place. The student can cancel the Enrollment Agreement without penalty by directly (in person, in writing, or by telephone) notifying the Program Administrator within 3 business days (excluding Saturdays, Sundays, and legal holidays) of the signing of the Enrollment Agreement. If cancellation notification is received within 3 business days (excluding Saturdays, Sundays, and legal holidays), full refund of any deposits will be made to the student or to a third party designated by the student within 14 days of receipt of the cancellation notification. If a third party makes the deposit payment, the deposit will be refunded to that third party. If a student chooses to cancel the agreement after 3 business days, no deposit refund will be made.
